

Iowa Abortion Resources

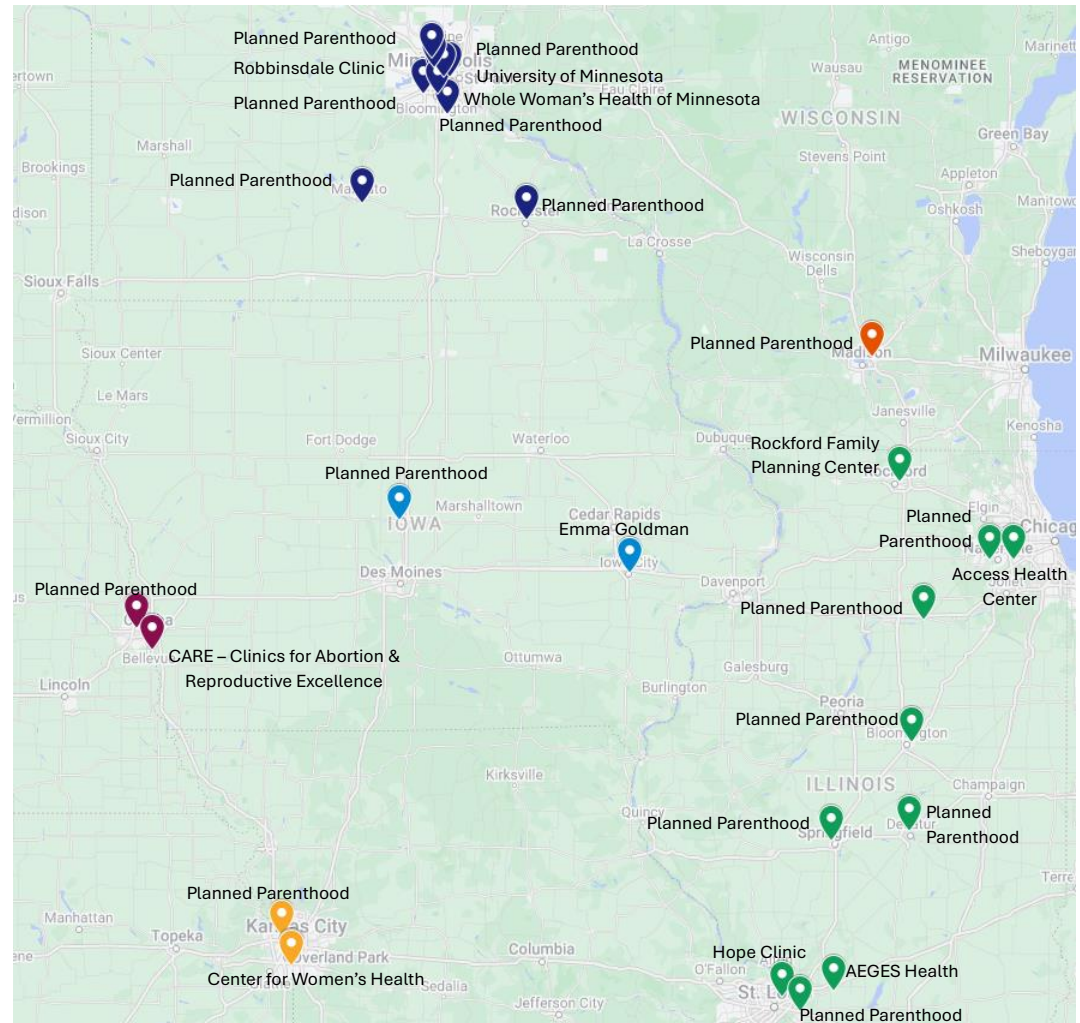
Reproductive health care, including access to birth control and safe and legal abortion care, is an essential part of health and well-being. While Roe v. Wade was overturned, abortion remains legal in many states, and other reproductive health care services are protected by law. Abortion remains legal in Iowa up until 20 weeks, however a law limiting abortion at the time at which cardiac activity can be detected, which typically occurs around six weeks of pregnancy, is expected to go into effect very soon. Iowa also requires clients to go to a state-directed information appointment in person, wait for 24 hours, and then go back for another appointment for an abortion. This means clients must make at least two trips to the health center. For more on your rights and legal protections, visit reproductiverights.gov/.

Surrounding State Regulations:

State	Regulations
Minnesota	Not restricted based on gestational duration
Illinois	Banned at fetal viability, generally 24-26 weeks
Kansas	Banned at 22 weeks and later
Wisconsin	Banned at 22 weeks and later; 2 trips required, one for in-person counseling and another 24 hours later for the abortion, ultrasound required
Nebraska	Banned at 12 weeks and later; 24-hour waiting period after counseling (not required to be in person); medication abortion provided in person
Missouri	Completely banned with very limited exceptions
South Dakota	Completely banned with very limited exceptions
